



## **COMPETITION REGULATIONS**

# **“Sound - Brain Activator”**

### **§ 1 GENERAL PROVISIONS**

1. The competition is organised under the name **“Sound - Brain Activator”**.

The organiser of the Competition and founder of prizes in the competition is IQ ACADEMY Education, Support, Development, address: 10-12 rue Leon Thyes; L-2636 Luxemburg. The competition is conducted only on the Internet on the website <http://iqacademylux.eu> and <http://tomatis.iqacademylux.eu> as well as Facebook profile <https://www.facebook.com/IQAcademyLux> in the period 17 July- 10 of September 2017 (until 12:00 noon).

### **§ 2 TERMS AND CONDITIONS OF PARTICIPATION IN THE COMPETITIONS**

1. The participant of the Competition (“Competition”) can be any natural person who: a) has the full legal capacity. The persons with limited legal capacities participate in the Competition upon the consent of their statutory representative or legal guardian. b) is not an employee or family member of IQ Academy Luxemburg.

2. The condition of participation in the Competition is joint fulfilment of the following conditions: a person participating in the Competition must have a Participant status under § 2 point 1.

### **§ 3 PRIZES**

1. The competition prizes are:

- Voucher for Therapy conducted with Thomatis Method (2 levels), (an equivalent of Euro 1 300.00).
- Voucher for lessons in breathing with a diaphragm (8 sessions), (an equivalent of Euro 327.60)
- Voucher for lessons in child massage (4 sessions), (an equivalent of Euro 80.00)

3. In order to ensure correct organisation of the Competition, the Organiser appoints the competition commission. All and any doubts as to the rules of the Competition, interpretation and provisions of these Regulations are solved by the Organiser.

4. The competition winners are notified of the prize by the Facebook portal within 5 (five) working days upon the end of the Competition.

5. In order to confirm the willingness to accept the prize, the notified person shall reply by means of the electronic mail to the address iqacademylux@gmail.com within 3 (three) days upon the date on which the notification is sent, under pain of losing the right to the prize.

6. The awarded prize is sent to Winners of the Competition on the cost of IQ Academy Luxemburg to the address provided by Winners, in the territory of G.D. Luxembourg, within 10 working days upon the date on which the Winner sends the required data.

7. Under these regulations, each participant releases the Facebook portal from the responsibility for the competition conducted by IQ Academy Luxemburg.

8. The competition is not sponsored, supported or conducted by the Facebook portal in any manner nor connected with it.

#### **§ 4 PERSONAL DATA OF COMPETITION PARTICIPANTS**

1. The conditions of participation in the Competition:

- b) sharing of the post below (regarding the Competition) on one's own Facebook profile,
